

The City Council of the City Council of Monticello, Florida met in special session on September 5, 2019 at 6:00 p.m. at City Hall for the purpose of conducting the 2019-2020 Tentative Millage and Budget Hearings. The following members were present:

Mayor John Jones called the meeting to order. Police Chief Fred Mosley offered an invocation, and Mayor Jones led the Pledge of Allegiance.

Mayor Jones announced that the purpose of the meeting was to conduct public hearings and to adopt a tentative millage rate and tentative budget for the City of Monticello for the 2019-2020 fiscal year. The tentative millage is 7.2000 mills, which is an increase of 2.18 percent over the rollback rate of 7.0463 mills.

The reason for the millage increase is to continue to maintenance of current city service levels and to continue to make improvements in the neighborhood and business communities.

The proposed budget for 2019-2020 is \$8,177,816.
